**CASE NARRATIVE 3/30/2010 5:56 AM**

I Officer D. Barnes was working in an off duty capacity at Club Rain during the listed date and time. While working there I observed complainant Anshonae Mills being escorted out of the club by club security. Once outside the club Mills advised this officer that she had been battered in the club by a male. She advised this officer that she was hit in the face with a glass by a male who was later identified as Santonio Holmes. Mills Had several other ladies with her. Those ladies and I went back into the club. Once back in VIP they pointed out an individual who was escorted outside of the club by this officer. Once outside Mills advised this officer that he was the wrong guy. We then went back into the club where they then pointed out Holmes. I then escorted Holmes outside the club. Once outside the club I asked Mills if Holmes was the suspect. She advised me that Holmes was the male who had struck her with the glass. Holmes immediately denied ever touching Mills. Holmes advised this officer that they were all in the VIP section of the club. He said that he had gotten up from his seat and when he returned Mills was sitting in his seat. He advised that he asked Mills If he can have his seat back and she said no. He stated that he then turned to walk away from her and she grabbed his wrist. He advised that he snatched away and she then stood and got in his face and called him a `fuck nigger`. He advised this officer that a woman in club then threw a glass striking Mills in the face. Mills advised that she was approached by Holmes in reference to a VIP seat. She stated that Holmes was angry over the seat. She advised that he then got in her face over it and then later struck her with a glass. After hearing conflicting statements from both parties and no independent witnesses this officer advised them that I would need everyone to write sworn written statements. I advised them that I would file charges against Holmes and they would later be given a court date. Mills then asked this officer if she could speak to Holmes alone. I said yes and Holmes agreed to speak with her. They then walked several feet away
